# AMI Montessori for Dementia, Disability and Ageing Workshop

#### **Workshop content**

#### By the end of the workshop, participant will be able to

- · Connect the needs, interests, skills, and abilities of people with dementia or disabilities to the goals of Montessori.
- · Describe the Montessori model of the aging and dementia approach and why it is an effective approach to increasing independence and quality of life
- · Learn about Montessori philosophy and the basic Montessori principles and how they relate to aging, dementia and disability.
- Design a Montessori environment using Montessori Principles of Ageing and Dementia, and design and deliver activities for individuals and groups.
- Evaluate current environmental strategies and be capable of modifying them to provide a Montessori prepared environment for those with aging and dementia.

After completing the three-day workshop, participants can obtain an AMI certificate of participation. Participants can choose to complete the AMI Aging and Dementia Practitioner Certification within 6 months of completing the course.
